

Terms & Conditions

General

1. 'PCSB' refers to Phillip Capital Sdn Bhd
2. Client refers to PCSB client.
3. Existing clients refer to current clients who have a stock trading account with PCSB.
4. New clients refer to participants who have successfully opened a U.S Stocks Trading Account paired with US Market Live Data with Phillip Capital from 20th January 2025 onwards till 31st March 2025.
